Covid Update

It really is great that life is very close to being back to normal. We still need to maintain some precautions so here is where we are at.

- If you're visiting, we will get you to test when you arrive. If the result is negative than all can be normal.
- If you do not want to have a test, you will need to wear a mask while you are inside one of the homes.
- Masks are still being worn while in vehicles and indoor spaces where it's difficult to maintain social distance (regardless of test result).

Some of the day to day

On an operational level we have a mid-point audit/evaluation primarily on the Kingseat property in November. We will also be audited around some other people supported who have what is considered high funding. This process will take a week.

By the end of October, we will have caught up on all mandatory training for the team including First Aid and de-escalation training. Five staff are studying their level 4 qualifications and five are studying their level 3 qualifications. Other learning is primarily focused on getting our new staff embedded in their teams and getting to know your loved ones.

Our goal planning calendar is getting back on track and most staff who have been smashing out long hours while we have been recruiting have managed to take a well-earned break.

We are also catching up on repairs,

maintenance and decorating as trades people become available and have some lovely small gardens coming along nicely – bring on summer.



Let's get excited about the future

It is just fantastic that we can *finally* start making plans for the future – from Christmas plans, to thinking about summer holidays right through to big audacious dreams for the longer term.

This year nine of your loved ones have secured employment or have changed jobs – a real reflection of what's happening in the job market. There has been a broadening of community engagement with more people volunteering and exploring new hobbies and social events. It's inspiring to see this stretching out beyond Covid and sets a great example to all of us.



At the risk of being repetitive – we really, *really* need you to get back to us about the home agreement, consent for support and the Christmas party, so I look forward to hearing back from you in the next week or two.
